

BYLAW # 44/90

A BYLAW RESPECTING THE EXPROPRIATION OF LAND

The Council of the Village of Kannata Valley in the Province of Saskatchewan enacts as follows:

s/b SE - see Bylaw 51/91

1. Council of Kannata Valley Saskatchewan deems it necessary to acquire the portion of NE & NW # 18-21-21-2 as described in Schedule "A" attached hereto.
2. The said land being zoned for non residential purposes and with a Ministerial Decision prohibiting a development, is best protected as a Passive Park as provided for in Kannata Valley Basic Planning Statement October 18, 1987, Item 1, Recreation Policy.
3. The said land is owned by Amalco Credit Services Ltd., 2129 Broad St., Regina, Saskatchewan.
4. After discussions with the owner the Council has been unable to acquire the land by agreement.
5. Therefore it shall be lawful for the Council of the Village of Kannata Valley, Saskatchewan to expropriate the land hereinbefore described for use as a Passive Park, and the said land is hereby expropriated on behalf of the said Village of Kannata Valley in accordance with the provisions of the Municipal Expropriation Act.
