

GENERAL INFORMATION AND HIGHLIGHTS

RADON MITIGATION IN SASKATCHEWAN

Radon is a colorless, odorless, and tasteless radioactive gas released when uranium decays. Homes built on soil containing uranium can be flooded with radon gas when there are cracks and gaps in foundation walls and basement floor slabs. Radon that enters homes poses a health risk, as long-term exposure to radon can increase the risk of lung cancer. The risk is particularly significant in areas with high radon concentrations in the soil, such as some parts of Saskatchewan.

Regular testing for radon is recommended. If levels are above the limits recommended by Health Canada, systems can be installed. Such systems typically involve installing either an active or passive ventilation system below basement floor slabs and sealing radon gas entry points in slabs and foundation walls. OFFICIAL COMMUNITY PLAN AND ZONING BYLAW

Many of you have been seeing emails regarding these two bylaws. As a legislative requirement, all municipalities must have an Official Community Plan (OCP) and Zoning Bylaw. The government of Saskatchewan provided funding opportunities for municipalities to have these bylaws developed. The Village was one of those municipalities who did not miss out on this funding, and although this has been a long process, we are looking forward to final government approval of our draft bylaws.

It is important to note, like all bylaws, they too can be amended when needed. These two bylaws create the social, economic and cultural basis of the community, so any amendments made must follow the same governmental final approval process.
